## **ABOUT CONFERENCE 2017**

We look forward to welcoming home all Jamaicans, to the 2017 gathering in the heart of Kingston!

The Jamaica 55 Diaspora Conference under the theme "Partnering for Growth" promises to be an informative and rich experience. Since its inauguration in 2004, the Diaspora Conferences have been expanded to emphasize the invaluable contribution of Jamaicans living overseas to include in the Programme, Investment and innovative Business opportunities, Health, Education and Social Enterprise Development, to name several areas of interest. The 2017 programme has been further invigorated to add even greater vitality and relevance to the Conference format and the planned exchanges with participants.

Convened every two years by the Ministry of Foreign Affairs and Foreign Trade, this conference is an important platform in Jamaica's strategic effort to meaningfully engage with you, Jamaicans dispersed around the globe. The event brings together Jamaicans at home with Jamaicans and persons of Jamaican descent abroad who include Diaspora business interests, philanthropic individuals, organizations and groups, and young people of Jamaican descent.
